Pursuant to a conditional Share Sale Agreement entered into between Lion Forest Industries Berhad ("LFIB") and Tan Sri Cheng Heng Jem ("TSCW") on 30 September 2016 ("SS Agreement"), LFIB agreed to acquire from TSCW 5.18% of the voting shares in Parkson Holdings Berhad ("PHB") ("Transaction"). Lion Industries Corporation Berhad ("LICB") holds directly and indirectly 74.06% of the voting shares in LFIB. LICB holds directly and indirectly through LFIB and Amsteel Mills Sdn Bhd a total of 28.14% of the voting shares in PHB. PHB, through its wholly-owned subsidiary, East Crest International Limited ("ECIL"), holds 67.96% of the voting shares in Parkson Retail Asia Limited. Hence, LICB is deemed to be interested in the shares held by ECIL by virtue of Section 7(4A) of the Companies Act, Cap 50. LICB had made the notification on 04 October 2016 upon the entering into the conditional SS Agreement in relation to the Transaction. The Transaction was completed on 14 October 2016.
